1. STFADELESS 6 MET STGOAL 1 NIGHT 12 OCT. DISCUSSION ADDED LITTLE TO INFO REPORTED REF. STGOAL 1 SHOWED NO SPECIAL INTEREST IN MONEY HELD FOR HIM BY STFADELESS 6 AND AS IN CASE OF \$1200 HELD BY LARSON JUST ASKED STFADELESS TO KEEP IT. PASSES RESULTS LARSON AND STFADELESS MEETINGS WITH STGOAL, IT APPEARS STGOAL IS SATISFIED AT LEAST RESIGNED TO HIS LIFE ON THE MAINLAND.
