1. SUBJ REF DEPARTED MEXICO 19 SEPT VIA SABENA FLIGHT 556 FOR MONTREAL. PER LIFEAT COVERAGE 14 SEPT SHE TOLD JAN SLUSARZ, POLISH INTEL OFFICER MEXI, THAT SHE PLANNED SPEND THREE DAYS ENGLAND, TWO WEEKS FRANCE AND BE BACK IN POLAND BY 18 OCT.

2. COACID NAME TRACE REQUEST MAY BE DELAYED REACTION TO SUBJ'S UNSUCCESSFUL ATTEMPTS GET PBPRIME VISA IN MEXICO. ALTHO NOT REFUSED VISA, VISA OFFICERS SAT ON REQUEST SO LONG THAT SUBJ GAVE UP PLANS VISIT PBPRIME.

3. DURING SUBJ'S STAY MEXICO WE MONITORED HER ACTIVITIES THRU LIFELOD AND STAFF AGENT SEYMOUR D. TRINNICK. THERE NO INDICATION INTEL ACTIVITIES, BUT ON OTHER HAND NO SIGN OF POSSIBLE SUSCEPTIBILITY TO RECRUITMENT. CONTINUED ATTEMPTS BY LIFELOD TO DETERMINE WHAT ACCESS SUBJ HAD TO INTERESTING PERSONALITIES AND SOURCES INFO POLAND RESULTED IN ASSESSMENT SHE EITHER DOES NOT HAVE SUCH CONTACTS OR IF SHE DOES IS
