1. MICHAEL C. CHOADEN HAS RECEIVED LETTER FROM PENUMBRA. FOL IS GIST: "I HAVE BEEN TRYING TO FIND YOU FOR A LONG TIME BUT I HAVE UNFORTUNATELY NOT FOUND OUT WHERE YOU WERE UNTIL A FEW DAYS AGO WHEN I MET A FRIEND CALLED ALBERTO SLIM (CHOADEN ACQUAINTANCE) WHO HAD SEEN YOU IN MEXICO. THE REASON I WANT TO FIND YOU IS BECAUSE I WOULD LIKE TO FIND OUT IF YOU ARE PREPARED TO HELP ME IN THE MATTER IN WHICH I GOT INVOLVED SOME YEARS AGO. YOU WERE RIGHT WITH ME AT THE BEGINNING OF (PECTATE) AND ARE CERTAINLY AWARE OF ALL THE FACTS MORE THAN ANYONE ELSE. I HAVE NOW FOR OVER A YEAR BEEN HAVING TERRIBLE TROUBLE AND I WAS EVEN BLACKMAILED IN TRYING TO ARRIVE AT AN AMICABLE SOLUTION WITH THE PRINCIPALS IN WASHINGTON. HOWEVER ALL THE PEOPLE INVOLVED HAVE TURNED THEIR BACK ON ME, AND DESPITE MY REPEATED LETTERS AND TELEGRAMS TO SEVERAL OF THEM I HAVE NOT EVEN HAD A REPLY. I SOMEHOW FEEL THAT YOU ARE NOT LIKE THEM AND THAT YOU WILL ANSWER MY REQUEST FOR FINDING AN AMICABLE SETTLEMENT. HOWEVER BEFORE I GIVE YOU THE DETAILS OF THE CASE AND EMBARRASS YOU WITH THEM, I WOULD RATHER HEAR FROM YOU WHETHER YOU WOULD BE PREPARED TO TAKE ACTION OR OTHERWISE".
