NOTE SECOND PICKUP WHICH MADE ON GCM INITIATIVE WITHOUT
PRIOR CONSULTATION WITH STATION OR POSSESSING OBTAINING EVIDENCE
GREAT DESIRE MEXICAN AUTHORITIES TO DE OF SERVICE. IMMEDIATELY
AFTER PICKUP ECHEVARRIA HAD RECEIVED INSTRUCTIONS FROM
LITENSOR PERSONALLY NOT TO RELEASE DURAN UNTIL CURTIS SAID
SO. AT HQ REQUEST CURTIS FURNISHED INTERROGATION QUESTIONS
TO ECHEVARRIA NIGHT 27 NOV. IN VIEW REF FELT NO ALTERNATIVE BUT

NOVEMBER.
