Reference is made to your memorandum dated 21 September 1962 requesting an appropriate investigation of Subject in connection with his use under an Operational Approval as an informant by WH/3-Mexico, D.F. Reference is also made to our memoranda dated 6 October 1960, 1 May 1962 and 17 October 1962.

2. The enclosed information is furnished as an aid in determining whether or not the Subject should be used in the proposed capacity.

3. In view of the certification set forth in your request, no CIA files other than those of the Office of Security have been searched in connection with this case. It is assumed that all pertinent information concerning the Subject has been furnished pursuant to the provisions of Clandestine Services Instruction No. 10-5 and Clandestine Services Instruction - Field No. 10-5.
