1. Mr. Phil Bowers, WH Division, requested information regarding the Subject who is to be converted from a contract agent to a staff employee. Mr. Bowers advised that Subject is currently in headquarters and WH would like for the necessary processing to be completed prior to Subject's return to Panama. *next week.*

2. Mr. Bowers discussed this case with Mr. J. C. King. Mr. King indicated that both the IG and Mr. Helms are familiar with this case and although Mr. Helms has not formally approved Subject's conversion to staff employee, however, Mr. King believes he is fully knowledgeable of it. The IG has indicated he would interpose no objection.
