Subject, a WH asset asset, died after being stricken with an acute coronary thrombosis at Dulles Airport enroute to CIA Headquarters. He was DOA at Fairfax Hospital. The case was delicate in that Subject was traveling under alias and was registered at the hospital under alias.
