Mr. Ford requested a representative of this Agency to obtain a statement from Major Adrian F. Sherman, an employee of this Agency, concerning a statement that Sherman is alleged to have made that the State Department installation where Mr. Ford is presently located "is full of homosexuals".

The above request for information was informally made and transmitted to this office through channels of this organization.

Major Sherman has been interviewed and he advises that he never made any such statement as alleged. He further advises that he has no information which would indicate any possible tendencies on the part of any employee of the State Department.

It is requested that Mr. Ford be advised through your channels of the above results of the interview.
