Mercy MARTINEZ is listed by the Cuban Foreign Ministry as Sub-Director of the Secretariat of the Ministry. Her immediate superior is Juan Nilo *OTERO Rodriguez for whom she signed the letter of Reference A.</p> <p>3.
