2. IN SPITE DISCREPANCIES, WHICH CAN EASILY BE ATTRIBUTED TO HASTE AND CARELESSNESS ON PART OF BORDER PERSONNEL, HAGU INCLINED BELIEVE ABOVE DATA REFERS TO OSWALDS WIFE MARINA.
