AMENDED COMMENT

This document was released with portions deleted. The deleted portions contain information confirming the existence of an Agency station in a specific city abroad, information identifying an Agency staff employee and FBI special agents, Agency internal filing instructions and information which if released would tend to confirm the existence of an Agency intelligence operation (in this instance one conducted jointly with a foreign liaison service). The deletions were made under the authority of exemptions (b)(1), (b)(2), (b)(3) and (b)(7)(F). The FBI special agent's name was deleted at the behest and request of the FBI.
