1. AIR FORCE INTELLIGENCE ADVISES THAT [redacted] D

[redacted] D USAF ASSIGNED TO [redacted] D HAS BEEN IN TOUCH ASKING ASSISTANCE IN CONTACTING AN [redacted] C OFFICIAL.

[redacted] D CLAIMS THAT HIS DAUGHTER [redacted] D, WHO FORMERLY WORKED IN [redacted] D FOR LAW FIRM AND IS NOW BASED IN [redacted] D WITH [redacted] D HAS TELEPHONED HIM FROM [redacted] D APPROX EIGHT TIMES IN LAST SEVERAL NIGHTS. SHE STATES SHE IS IN THE HANDS OF [redacted] C SHE CLAIMS THAT SHE KNEW JAMES EARL RAY AND SHE KNOWS HE WENT TO LONDON. SHE FURTHER CLAIMS THAT [redacted] C IS PAYING FOR HER PHONE CALLS, AT THE SAME TIME IMPLYING, AT LEAST AS FAR AS [redacted] D IS CONCERNED, THAT SHE IS UNDER A CERTAIN AMOUNT OF DURESS.

2. [redacted] D IS VERY DISTRAUGHT AND CONCERNED FOR DAUGHTER'S WELFARE. AIR FORCE ADVISED HIM THAT THEY WOULD TRY TO PUT [redacted] C IN TOUCH WITH HIM. THEY HAVE ASKED HIM NOT TO DO ANYTHING DRASTIC, SUCH AS SURFACING MATTER TO THE PRESS,
