AS YOU KNOW WE WANT THIS ONE BADLY AND WILLING MAKE ANY REASONABLE GUARANTEES BOTH MONETARY AND OTHERWISE FOR STEADY FLOW OF GOOD INTEL OVER DEFINITIVE PERIOD OF ONE YEAR OR MORE.
