1. IN RESPONSE TO YOUR REQUEST WE SUBMIT VERBATIM A MEMORANDUM FOR THE RECORD AFTER A SIGNIFICANT MEETING WITH LNERGO DEALING WITH THE SUBJECT OF THE TORRIENTE GROUP. WHEN THE ADDRESSEE READS THE MEMORANDUM THEY CAN UNDERSTAND WE DID NOT MAKE THE STATEMENT ALLEGED IN REFERENCE. ON THE OTHER HAND, IT IS ALWAYS POSSIBLE THAT A MEMBER OF LNERGO, MIAMI, WITH THE BEST OF INTENTIONS, IN PROTECTING JKLANCE MIGHT HAVE MIS-INTERPRETED WHAT WAS SAID.

2. IN THE MEMORANDUM, PARA 2, SUB-PARA D, WHICH REFERS TO COS PERSONAL INVOLVEMENT WITH THE VESSEL, MEANS SIMPLY THE FOLLOWING: WHEN JKLANCE DISASSOCIATED FROM THE ARTIME OPERATION, THE MOTHER VESSEL WAS DROPPED DEAD IN THE WATER OUTSIDE OF PANAMA AND PONCHAY, THEN COS, MIAMI, HAD TO ARRANGE WITH THE NAVY TO DRAG SAID VESSEL INTO GATUN LAKE AND USE A "COMPANY OF SPECIAL FORCES," IN CIVIES, TO DISPOSE OF SEVERAL TONS OF WEAPONS IMPROPERLY PACKED, WHICH COMPRISED THE CARGO OF
