COMBAT REPORT, 1st of Nov. Noemayr
Plaza Nacional, Miraflores block, 3:30 PM

1. Spoj was contacted according to prearranged phone conversation date at the same place where he met the CGR several weeks ago. Most of the contact was devoted to general discussion of current ops and future plans.

2. Noemayr is very optimistic about the developments of LITFIA. This man has been following a pattern, unknown to me, that leads to hitting recruitment. He has expressed the desire to conduct exchanges of information in a clandestine manner, thus indicating that he recognizes that he is doing something that he would not want to get caught at. There is no need for us to be concerned about popping the question since the time will arise with him when he will suddenly realize that he is and has been working against his own organization and that he has become a penetration agent. At that time, his motivation toward playing the game will increase as it does with most reliable agents. LITFIA represents placement in the top three or four persons in the CGOM, PP and CIA and can be a most valuable asset once fully recruited. It was therefore judged advisable to wait for a better cutout than LITFIA to show up before really trying to train the agent, rather than substituting a cutout right now with LITFIA. LITFIA is a man who would be very harmful since he does not get along with people. It was decided to retain J. J. J., who has at least good rapport even though he doesn't catch on to the intelligence racket.

3. Noemayr has been going through the archive files maintained by Postary and has suggested that I call into numerous bars, analyze on key CGM-POS, PP figures, he suggested that I both might run over there together some afternoon at his home so that I might see what he has and then see where I can add details from the office. His wife works and the maid is accustomed to seeing visiting gringos. I left Noemayr on maintaining files, but he seemed confident that all is secure in his home. I shall pursue this topic later with him.

4. We made arrangements for the next meeting: Parque de las Americas, 5:00 PM, Friday 7 Nov. I will be on foot, he by car. If no danger, I will definitely head toward him as he approaches counterclockwise to my walking. Otherwise, he will drive away and return in ten minutes.

5. We ended by his driving me through the area in which he lives so as to let me judge for myself as to the environment around his place in case I decide to stay target analyses at his home.

6. Noemayr passed several reports and ops data, received in turn selection for self and LITFIA.

OF SPECIAL IMPORTANCE:

During our conversation regarding the FBI, CGS penetration program, he mentioned that his wife had suggested an operational possibility. That is of interest is that she is apparently intimately aware of his confidential activity. He himself said that in Costa Rica when he first started the LITFIA program she used to meet the agent when he (Noemayr) could not make a contact. It was recorded that during my recent debriefing of HUMA-0113, the agent asked about her. I made a noncommittal answer and asked why did he ask? The agent replied that one of his greatest fears is that Noemayr and his wife might part ways and she return to the CGS. The agent explained that she had two brothers, one of whom was in the CGS and the other was in the CGS.

is a SNOEMAKER WHO USED TO BE A PVP MILITANT AND WHO LIVES IN SAN JOSE. (Agent is a
a snoemaker) He fears that if Noemayr and wife separated, she might reveal her knowledge
of HEMNOD-3 to her brother or to someone who would also get word back to the Party.
The implications in Mexico appear to equally great, if she should be aware of LIONEL
LIFTER and our other penetrations.
