1. Reference is made to your memorandum dated 13 May 1960 requesting that Subject be granted an appropriate security clearance to permit his utilization by CC/OS/TR. It is understood that Subject is currently in the United States and will be here for a period of two years and that WH Division has offered Subject's services in connection with practical exercises arising out of training activities on a "as needed" basis. It is further understood that Subject will not have access to Agency buildings and ISLIP. It is contemplated that he will have access to such safehouse facilities as is required by the respective training exercises and will be introduced to and know: trainees by training aliases only. It is further understood that Subject will not be used with liaison personnel nor foreign nationals who will serve in the South American area.

2. This is to advise that a covert security clearance is granted for the use of the Subject, as described in your request as set forth in paragraph 1, above. It is understood that Subject will remain the administrative responsibility of WH/Mexico, who will continue to provide work for Subject.

3. A memorandum containing pertinent information regarding Subject is being forwarded concurrently under separate cover.

4. Subjects of covert security clearances are not to represent themselves as, nor are they to be represented as, employees of CIA.

5. Your attention is called to the fact that a covert security clearance does not constitute complete compliance with the provisions of CIA Regulation 10-210. Therefore, if you should desire at a later date to change the status or use of this individual, a request for clearance to cover any proposed change should be submitted to this office.
