7. (Internal Use Only - LLM) LIAISON Met with Senator H. John Heinz (R., Pa.) and his aide, Mark Bisnow, and reviewed with them the information we had retrieved on the ownership of Air Taxi Company. Senator Heinz had two additional questions and he had no problem with having these questions go through Ken McLean, Staff Director, Senate Banking, Housing and Urban Affairs Committee. The questions related to whether we had made an inquiry of former COS' who served in Tehran in early 1970 and whether we had any information on a showing in Iran of a Bell Helicopter film which was attended by the Shah of Iran and General Khatami. The tenor of the questions from Bisnow and the Senator seemed to suggest that they felt we should have been more active in investigating all aspects in Iran which may be of interest to the Banking Committee, but I said that we had no way of knowing what that would be, and the only way we could provide was on the basis of specific questions, and the Senator agreed.

8. (Internal Use Only - LLM) LIAISON Saw Mike Epstein, Senate Select Committee on Intelligence staff, to determine what role the Committee felt would be their responsibility to play in determining releasing and controlling access to testimony and material developed by the Church Committee which the staff of the House Select Committee on Assassinations is interested in reviewing.

9. (Unclassified - MLG) LIAISON Per Robert Kelso's request I forwarded to Dorothy Fosdick, of the Senate Governmental Affairs Permanent Subcommittee on Investigations staff, one copy of a recent speech given by Chinese diplomat Liao Cheng Chih.

10. (Unclassified - RJK) LIAISON Talked to a member of Representative Charles Bennett's (D., Fla.) staff in response to their reminder that they had not received a response to the Congressman's inquiry on behalf of their constituent, Marcus Conant. I advised her that a response had been sent out from our office on Monday, 30 January 1978, and apparently our two letters crossed in the mail.
