This is to acknowledge your letter of 16 August 1995 to Director of Central Intelligence Deutch describing the Assassination Records Review Board's most recent formal determinations with respect to CIA records.

The appropriate Agency components have again reviewed the 37 documents which the Board has decided to release, either fully or with some information postponed. Please advise the Board that the Agency does not plan to appeal to the President for additional postponements with respect to the documents listed in your letter.

We understand that further review will be needed by December 1995 to determine if additional information in a number of the documents can be released. We would be pleased to discuss with the Board and your staff any issues that may arise with regard to declassifying and releasing CIA-originated information.
