Mr. STRINING said that he called a telephone number in NYC, the exact number he is unable to recall at the present time, in connection with this matter. Mr. STRINING said he spoke to an unknown female who answered his phone call, and this unknown female advised him that "RICHARD FRANK and his wife are in Red China, don't you know that?". Mr. STRINING was unable to recall this number but will endeavor to locate the original deposit of \$199.50 to determine if there is any clue there as to the phone number he called.
