FD 122 has been submitted reflecting change in subject's employment. A review of her SI card reflects the remaining information to be current and correct. A suitable photograph of subject is available.

Subject is being retained on the SI in view of her attendance at several CP meetings from January through July, 1956, and her admission that she was not running out on the Party.

An interview of subject is not being contemplated inasmuch as she has refused to talk to Agents when interviewed on 1/16/53, 6/2/55, and 4/5/56.
