CIA ADVISES THAT LUIS ECHEVERRIA, ACTING MINISTER OF

 "FASCINATING."

SILVIA DURAN RELEASED BY MEXICANS 6 PM YESTERDAY BUT
 REPORTEDLY CONTINUES TO BE UNDER HEAVY SURVEILLANCE AND SUBJECT
 TO BEING ARRESTED. RESULTS OF HER INTERROGATION NOT YET
 RECEIVED BUT UNDERSTOOD SHE GAVE NO NEW INFORMATION.

PRESS HERE ANNOUNCED TODAY THAT MEXICAN GOVERNMENT HAD
 REJECTED CUBAN DIPLOMATIC NOTE WHICH PROTESTED ARREST OF DURAN

WHEELOCK GARCIA OF NICARAGUAN INTELLIGENCE SERVICE IS ARRIVING MEXICO CITY TODAY TO BE AVAILABLE TO ASSIST MEXICANS IN INTERROGATION OF ALVARADO IF SUCH ASSISTANCE DESIRED. *(s)*

THIS MORNING AMBASSADOR MANN EXPRESSED TO US HIS GREAT PLEASURE ON AUTHORIZATION GIVEN FOR CIA TO MAKE ALVARADO AVAILABLE TO MEXICANS. HE STATED HE FELT THIS WAS ONLY WAY TO RESOLVE QUESTION OF VERACITY OF ALVARADO'S STORY. *(u)*

IN VIEW OF FACT THAT ALVARADO'S INTERROGATION BY MEXICANS IS CONTINUING IT IS BELIEVED THAT SUBMISSION OF DETAILED MEMO COVERING INVESTIGATION TO DATE IN MEXICO SHOULD BE HELD IN ABEYANCE UNTIL FINAL RESULTS OF INTERROGATION OF ALVARADO AVAILABLE. UACB THIS WILL BE DONE. *(u)*
