WINSTON M. SCOTT, HEAD OF CIA, MEXICO CITY ADVISED WAS IN-
 FORMED BY CAPTAIN WHEELOCK, NICARAGUAN INTELLIGENCE SERVICE
 REPRESENTATIVE, THAT ALVARADO TOLD HIM THIS AFTERNOON THAT HE
 RECANTES HIS ORIGINAL STORY BECAUSE OF FEAR OF PHYSICAL HARM.
 ALVARADO BEING DEPORTED TO NICARAGUA ON DECEMBER 4 NEXT AND WILL

SUGGEST BUREAU CONSULT WITH CIA HEADQUARTERS CONCERNING
 DESIRABILITY OF HAVING ALVARADO GIVEN POLYGRAPH EXAMINATION IN
 MANAGUA.
