THERE IS NO DOUBT IN AMBASSADOR'S MIND NOR IN OURS AS TO ROLE
WE ARE TO PLAY IN CONNECTION WITH INVESTIGATION HERE AND JOHNSON'S
CABLE MENTIONED ONLY FOR INFORMATION OF BUREAU IN ORDER THAT IT MAY
HAVE SOME IDEA OF WAY JOHNSON IS HANDLING MATTER THERE.

LUIS ECHEVERRIA, ACTING MINISTER OF GOBERNACION, THIS AFTERNOON
ADVISED CIA REPRESENTATIVE THAT INTERROGATION OF GILBERTO ALVARADO
UGARTE IS CONTINUING AND ECHEVERRIA FEELS THAT EITHER ALVARADO IS
TELLING TRUTH OR IS BEST LIAR HE HAS EVER SEEN. ECHEVERRIA
INDICATED TO CIA REPRESENTATIVE THAT IN GENERAL STORY TOLD BY
ALVARADO IS SAME AS THAT GIVEN TO CIA. ALVARADO CONTINUES TO STICK
TO DATE OF SEPTEMBER ONE EIGHT AS THE ONE WHEN HE SAW MONEY PASSED.
ECHEVERRIA RECOGNIZES THAT IT WOULD HAVE BEEN PRACTICAL IMPOSSIBILITY
