CONFESSED HE FABRICATED HIS STORY. PLS GIVE **LITTEMPO 4** OUR OFFICIAL  
THANKS FOR HIS HELP.

2. BECAUSE THE RESOLUTION OF THIS CASE WILL BE CLOSELY SCRUTINIZED  
IN THE UP-COMING REVIEW OF THIS ENTIRE EPISODE, PLS ASCERTAIN AND CABLE  
IN AS TIME PERMITS THE DETAILS OF HOW THE CONFESSION WAS OBTAINED;  
WHAT THREATS, PROMISES, INDUCEMENTS, AND TACTICS WERE USED BY  
**LITTEMPO 4**. WAS ALVARADO PHYSICALLY MISTREATED? MUCH? PLS LEARN  
WHETHER ALVARADO ACTUALLY DID HEAR THE FALSE RADIO REPORT ABOUT  
OSWALD'S MAKING A FIVE THOUSAND DOLLAR BANK DEPOSIT AND USE THAT IN  
HIS STORY.
