- LIC. LUIS ECHEVARRIA INFORMED COS AT 1800 HRS MEXICO TIME THAT SYLVIA DURAN AND HER HUSBAND HAD ALREADY BEEN ARRESTED. THEY ARE PRESENTLY UNDER INTERROGATION BY GOVERNACION AUTHORITIES.
- COS ASKED LIC. ECHEVARRIA TO TAKE MEASURES REQUESTED REFERENCE. ECHEVARRIA PROMISED TO TRY TO KEEP ARREST SECRET.
- ECHEVARRIA DEFINITELY PROMISED ALL INFORMATION OBTAINED FROM DURANS; SAID FIRST REPORT SHOULD BE READY BY 2000 HRS MEXICAN TIME.
- DO NOT BELIEVE IT WILL BE POSSIBLE TO KEEP ARREST FROM HER FAMILY AND FROM CUBAN EMBASSY VERY LONG.
