In connection with this Committee's investigation into the circumstances surrounding the death of President John F. Kennedy, we respectfully request access to the following list of documents:

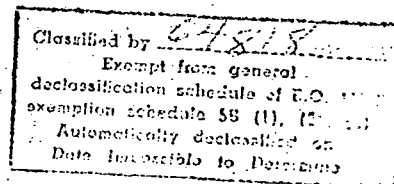
