- 5) MEXI-7625, dated in late 1963, concerning Rodriguez-Lopez.

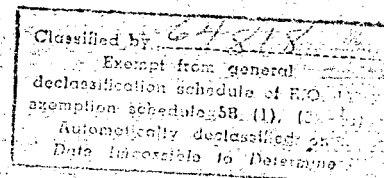
