GUS ALEX, AKA. AR. DAILY SUMMARY.

FRANK LA CROIX PAREN PROTECT IDENTITY END PAREN MANAGER OF APART-
MENT BUILDINGS AT ONE ONE FIVE ZERO AND ONE FIVE FIVE ZERO LAKE
SHORE DRIVE, CHICAGO, ADVISED THAT HE IS VERY UNHAPPY IN METHOD
USED BY ALEX IN RENTING APARTMENT TEN C AT ONE ONE FIVE ZERO LAKE
SHORE DRIVE BY HAVING HIS BROTHER SAM TAYLOR RENT APARTMENT IN HIS
NAME. STATED THAT APPROXIMATELY ONE YEAR AGO HE TURNED DOWN APPLICATION
OF ALEX FOR RENTAL OF APARTMENT AT ONE FIVE FIVE ZERO LAKE SHORE DIRVE
WHEN HE APPLIED FOR RENTAL UNDER HIS TRUE NAME. STATED THAT WHEN
SAM TAYLOR AND HIS WIFE RENTED APARTMENT TEN C AT ONE ONE FIVE ZERO
LAKE SHORE, GUS ALEX ACCOMPANIED MR. AND MRS. TAYLOR WHEN ARRANGEMENTS
WERE MADE FOR RENTAL AND AT THAT TIME HE DID NOT KNOW IDENTITY OF
GUS OR HIS BROTHER SAM TAYLOR. STATED THAT PRIOR TO MOVING INTO
APARTMENT, GUS ALEX ARRANGED FOR THE COMPLETE REDECORATING OF
APARTMENT INCLUDING FURNISHINGS. NOTED THAT APARTMENT FURNISHED
WITH WALL TO WALL CARPETING TWO INCHES THICK AND ARRANGED FOR INSTAL-
LATION OF MARBLE STALL SHOWER AND WASH BASIN WITH GOLD PLATE
FAUCET HANDLES OR WASH BASIN. STATED THAT HE WOULD ESTIMATE THE

OF TOWN REQUESTED PERMISSION OF HIM THAT GUS ALEX BE ALLOWED TO USE THE APARTMENT WHICH HE GRANTED. STATED THAT SAM/S WIFE HAD ARRANGED FOR MAID SERVICE TWICE A WEEK AND THAT THE LAST TIME THIS SERVICE WAS USED WAS ON APRIL FOUR LAST INDICATING THAT THE APARTMENT HAS NOT BEEN USED SINCE THAT DATE. INQUIRY AT NEIGHBORHOOD OF ALEX/S MOTHER, EVERGREEN PARK, ILL., INDICATED THAT ALEX/S MOTHER IS NOT OUT OF TOWN. INFORMATION PREVIOUSLY RECEIVED THAT ALEX HAD CONTEMPLATED A TRIP TO GREECE WITH HIS MOTHER. CG SIX FOUR FOUR THREE DASH C ADVISED THAT THE GENERAL TALK WHEN JAKE GUZIK WAS ALIVE, ALEX WAS HIS CHAUFFEUR, IS UNTRUE. HE STATED THAT HE CONSIDERED ALEX STRONGER THAN GUZIK AND MERELY LET GUZIK TAKE THE HONORS BECAUSE GUZIK WAS AN OLD MAN. HE STATED THAT ALEX EVEN MUSCLED JAKE GUZIK/S BROTHER AND MADE THEM KICK IN AND IF THEY DID NOT HE WOULD HAVE KILLED THE BROTHERS. MAIL COVER ON ALEX MAILING ADDRESS DISCLOSED HE RECEIVED MAIL ON FOUR EIGHT SIXTY ONE FROM THE GASLIGHT CLUB, CHICAGO. ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES. END AND ACK PLS.

Building manager unknown with method used by
Alex to obtain apartment by using his
brother Sam Taylor. Alex had apartment
completely redecorated including
He had 3" carpet installed, marble shower, gold
plated faucet handles on wash basin. Total cost
of decorating and furnishings approximate
\$10,000. Since renting apartment Alex has had
at least 6 different cars available to him, all
late models. These cars probably being made
available to him by Chicago car dealer Henry
Susk. All details re payment of rent for apartment
etc., being handled for Alex by Eugene Bernstein,
Chicago hoodlum tax attorney. Informant advises
Alex was more than just chauffeur for Jake Guzik
but was of equal power or possibly stronger.
