ROBERT W. WALSH, Customs Agent, United States Treasury Department, advised that ALEX returned from a trip to England arriving at the Customs Office in Detroit on May 9, 1961, but he had no record of a CHRISTINA ALEX on the same flight.

Attorney ALFRED A. MAY, 1150 National Bank Building, Detroit, who returned on the same flight as ALEX identified a photograph of ALEX as a man he observed on BOAC Flight Number BA 563 arriving at Detroit on May 9, 1961. He stated he recalled seeing ALEX walking around the terminal at Montreal at which time ALEX was alone. MAY was unable to furnish any additional information concerning connecting flights since he had been in London six days prior to the flight.

WILLIAM WHEELER, BOAC Office, Detroit Metropolitan Airport, advised that the passenger manifests reflect only the names of the passengers and no information regarding any connecting flights. He said such information could be available at Interline, London, England.

Inspector CHRIS PATSURIS, Athens City Police Department, on May 1, 1961, advised that GUS ALEX arrived in Athens, Greece, on April 4, 1961, via BEA Airlines from Milan, Italy. His address in Athens was determined to be the Athens Palace Hotel. ALEX departed Athens, Greece, by BEA Airlines on April 13, 1961, and again returned to Athens on April 16, 1961, from Rome, Italy.

Investigation conducted by the Athens City Police Department disclosed that one CONSTANTINE CONTOS also known as GUS CONTOS, resided at 29K Cotta, Athens, Greece. CONTOS is known by the Athens Police Department as a gambler and a big operator.
