CG 6502-C\* ADVISED THAT ALEX IS CONTINUALLY WORRIED ABOUT HIS HEALTH AND JUST YESTERDAY REMARKED TO HIS GIRL FRIEND, SUZANNE FUEGER, THAT HE THOUGHT SOMETHING WAS WRONG WITH HIM AND WAS GOING TO MAKE AN APPOINTMENT TO SEE HIS DOCTOR WHO IS GILBERT MARQUARDT.

MARQUARDT IS PCI OF THIS OFFICE.

IN THIS REGARD INFORMANT ADVISED THAT ALEX TOLD FUEGER THAT HE WANTED HER TO GET A COMPLETE PHYSICAL EXAMINATION AND THAT HE WAS TRYING TO CHOOSE BETWEEN TWO DOCTORS, NAMELY EDMOND FOLEY AND DR. MARQUARDT. ALEX TOLD FUEGER TO CALL MARQUARDT TO MAKE AN APPOINTMENT. ALEX TOLD FUEGER THAT HE WANTED HER TO MAKE THE ARRANGEMENTS AND IF HE WAS NOT SATISFIED WITH HIS FINDINGS SHE COULD THEN GO TO DR. FOLEY. ALEX STATED HE DID NOT WANT TO GET IN THE PICTURE BECAUSE ONE DOCTOR TALKS TO ANOTHER AND IT WOULD BE EMBARRASSING IF WORD GOT BACK TO MARQUARDT THAT HE IS SENDING FUEGER TO DR. FOLEY.

CLOSE CONTACT IS BEING MAINTAINED WITH FUEGER'S SUPERVISOR SHOULD SHE REQUEST ANY EXTENDED TIME OFF WHICH WOULD INDICATE THAT SHE WOULD BE ACCOMPANYING ALEX ON A TRIP.

ALEX ARMED AND DANGEROUS WITH SUICIDAL TENDENCIES.
