Enclosed for the Bureau are 12 copies of a LHM concerning recent activities of captioned organization. Dissemination is being made locally to ONI, OSI, INTC, G-2 and INS.

Two copies each of this LHM are also being furnished to San Juan and Miami for their information concerning JURE and anti-CASTRO files.

Tampa presently has under investigation a case captioned "UNSUBS; TRAINING OF CUBANS ON THE PROPERTY OF WEIR W. WILLIAMS, POLK CITY, FLORIDA", Tampa file 105-2383. Since this case apparently involves a violation of the Neutrality Act in the training and equipment of an armed force preparing for an attack against Cuba, this case is being handled separately and copies of reports will be furnished interested offices.
