On 6/7/61 PCI HERBERT LEERAY advised SA THOMAS G. FORSYTH, III:

Since the latter part of May, 1961, KELLY MANNARINO, his wife and two daughters, have been residing regularly at his cottage on RD #3, Old Leechburg Road, near Leechburg, Pa. With very few exceptions, their visitors have been mainly family groups for "cook-outs." Other than occasionally walking his dogs, KELLY does very little and merely sits in the yard sunbathing. There definitely have not been any "meetings" on a large scale basis, meaning three or more male visitors at any one time. KELLY does go to the Bonfire Restaurant frequently and may be meeting his friends there. The restaurant is only about 1/2 mile from the cottage on Route 58, and is believed to be owned by SAM MANNARINO, who also is frequently present there.

On 6/7/61 PG 615-C advised SA FORSYTH:

The basement room of SAM MANNARINO's Bonfire Restaurant, near Leechburg, Pa., is wholeheartedly believed to be a meeting place for the MANNARINOs and their associates. It has been fixed up with a table and chairs, and both MANNARINO brothers have been observed taking male associates down to that room for various periods of time.
