SUBJECT: LA CAUSA NOSTRA
ANTI-RACKETEERING - CONSPIRACY

On 5/9/63 PH 599-C-TE was contacted by SA DAVID E. WALKER. The informant was in a very friendly mood and was willing to answer questions (with in limits). At times the informant discussed matters concerning the organization for longer periods of time without prompting. He made it clear that he does not want to "hurt anyone" and will not give specific details regarding crimes known him. He said that any questions he would answer would be accurate to the best of his personal knowledge. His sources were personal observations during many years of activities in the Italian underworld as well as conversations with other persons who have been members of the organization for a longer period of time than himself. He pointed out that while he feels that he knows more concerning the general background of the organization that do most members
