Re San Juan airtel to Bureau dated 5/7/62,
and San Juan airtel to Bureau dated 4/27/62
entitled "Anti-FIDEL CASTRO Activities;
IS-CUBA".

On May 10, 1962, PSI (UD) ROBERTO ROCA ROSILLO, the original source in instant matter, advised that he did not furnish Lt. MACEO any names of ex-rebel fighter now living in Puerto Rico as he had planned to do. He stated that he decided against this until he learned more about the plans of MACEO's group.

ROCA stated that he had received a long-distance telephone call on May 8, 1962 from his friend and associate HIGINIO (NINO) DIAZ of the Movimiento Recuperacion Revolucionaria (MRR) in Miami, Florida, advising him to hold off in his efforts to assist MACEO's group until the matter is discussed further in Miami. PSI ROCA feels that MACEO and/or some of his group have very recently been in contact with DIAZ and the MRR in Miami.

ROCA further advised that Lt. NIETO, a representative of HUBERT MATOS' group in Puerto Rico, and he plan to visit Colonel RAMON M. BARQUIN LOPEZ upon the latter's return from his trip to South America.
