2. Will follow and report deportation proceedings regarding the subject.

ADMINISTRATIVE

It is to be noted that a 134 file was opened on the subject on 4/23/59, and was closed on 9/16/59, due to the fact that although PEREZ voluntarily furnished information which was of assistance in the location of the individuals in whom the Miami Office was interested, investigation conducted toward the establishment of PEREZ's reliability reflected that he was not considered reliable or trustworthy by individuals who have been in contact with him. Also, it was stated that he could not be depended upon to furnish all information in his possession if withholding some would be to his advantage.

This report is classified "confidential" inasmuch as it contains information the disclosure of which could reasonably result in the identification of confidential informants of continuing value.
