As a result of the interrogation of returning prisoners of war, G-2 has advised that captioned individual apparently cooperated with the Communists and is considered a security risk by G-2. Hibberd was assigned Army Serial Number 19360997 and has listed his home address as c/o Mr. Bernard Brener, 1228 South Lane Street, Burbank, California.

You are instructed to make appropriate arrangements to be notified of subject's discharge from military service. You should thereafter carefully review the [G-2 Intelligence Summary on this] subject which will be made available to you by the 6th Corps Area Commander to determine whether a security investigation is warranted.

Bureau authority is necessary prior to the institution of a security investigation. In this connection you should be guided by the instructions contained in SAC Letter Number 53-58.
