The enclosed memorandum has been classified ~~SECRET~~  
"SECRET" since the disclosure of the data could result  
in serious damage to the United States and could have  
a bearing on our National Defense. In addition, the  
unauthorized disclosure of the information contained  
in the memorandum may result in the identification of  
a source who represents good double agent potential  
and could possibly compromise his future effectiveness.

The individual who furnished SANCHEZ the  
information is MANUEL PRIETO, known as Manolo Prieto,  
and as "Chiquitico", who is the Secretary of the  
Triple A in New York. His identity was not set forth  
because to do so may possibly result in the identification  
of SANCHEZ. He met with SANCHEZ on 2/4/61, and had a  
long discussion with SANCHEZ. (u)

A new case is being opened on PRIETO and  
information concerning him furnished by SANCHEZ, will  
be set out in PRIETO's case file. (u)
