TWENTYTWO. BUREAU APPROVED INSTALLATION NOT WORKING IN PCI-S  
CAR, SINCE SHORTLY AFTER ~~FISUR~~ <sup>PHYSICAL SURVEILLANCE</sup> STARTED DALLAS. PCI DORIS HOWARD  
AND RUBY JELSEN ARRIVED NEW ORLEANS FOUR AM TODAY, CHECKED INTO  
COLONIAL HOTEL COURTS, STILL UNDER ~~FISUR~~ <sup>PHYSICAL SURVEILLANCE</sup>. HOWARD TODAY ADVISED

SA C. FRANK ALDEN, OKLAHOMA CITY, THAT JELSEN CLAIMED CONTACT  
WITH FRYE TO BE MADE BETWEEN EIGHT PM AND EIGHT THIRTY PM, TONIGHT  
OR TOMORROW NIGHT AT BAR, SEVEN THIRTY EIGHT TOULOUSE STREET.

CALLER WILL IDENTIFY HERSELF AS JOYCE THOMPSON AND ASK FOR JELSEN  
OR PCI BY NAME AND GIVE INSTRUCTIONS ON PLACE OF CONTACT WITH  
FRYE. HOWARD CLAIMS JELSEN STATED FRYE ADVISED POPE NEEDS TRANS-  
PORTATION TO A DOCTOR AND MONEY. TONY BACINO-S BAR IS AT SEVEN  
THIRTY EIGHT TOULOUSE STREET, NEW ORLEANS AND SO LISTED IN PHONE  
BOOK. JELSEN CALLED DALLAS FBI ELEVEN THIRTY AM TODAY, CLAIMED

FRYE TONIGHT EIGHT PM, POSSIBLY AT BAR ON TOUSON STREET, PHONETIC,  
OR SIMILAR NAME. JELSEN CLAIMS UNABLE TO QUESTION PCI FURTHER RE  
IDENTITY OF BAR. MEETING PLACE AND FRYE, IF SHE APPEARS, WILL BE  
COVERED. REMY CALL TO BUREAU TODAY AND BUREAU CALL TO NEW ORLEANS,  
MICROPHONE SURVEILLANCE
