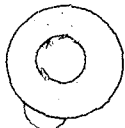

HARRY RAYMOND POPE, AKA, FUGITIVE, IO 3285, WF 229, UFAP-BURGLARY, ADW, DALLAS ORIGIN. OCREP SA CHARLES F. ALDEN DATED AUGUST 10 LAST AT OC AND PHONE CALLS OC AND DALLAS AUGUST 17 AND 18 INSTANT. PCI DORIS HOWARD, OC WORKING TELEPHONICALLY THROUGH MARJORIE LOFTICE AND RUBY JELSEN, BOTH DALLAS, SISTER AND MOTHER OF PEGGY ANN FRYE, LEARNED FRYE VERY ANXIOUS TO CONTACT PWI. PCI FURNISHED RUBY OKLAHOMA CITY PHONE NUMBER FOR RELAY TO FRYE 6:30 PM, AUGUST 16 LAST. APPROXIMATELY 2:30 AM, AUGUST 17 LAST, FRYE TELEPHONICALLY CONTACTED PCI, LONG DISTANCE, STATION TO STATION, SO PCI NOT INFORMED OF ORIGIN. PCI'S PHONE IS PERSHING 20879, OC. FRYE STATED ONLY SHE WAS QUOTE UP THE COUNTRY UNQUOTE, THE PHONE CALL WAS COSING HER QUOTE LAST PENNY UNQUOTE, SHE WAS WITH FRIEND BELIEVED BY PCI TO BE POSSIBLY POPE WHOM PCI HAS MET. THEY HAD NO CAR, HER FRIEND WAS SICK WITH STOMACH TROUBLE, THEY NEEDED TRANSPORTATION TO TRAVEL ABOUT 1200 MILES. PCI ASKED IF FRYE HAD SEEN HER FOLKS IN DALLAS. FRYE REPLIED QUOTE HELL NO, DO YOU THINK I AM CRAZY UNQUOTE. PCI STATED SHE MUST QUOTE HAVE A LOT OF HEAT UNQUOTE. FRYE REPLIED QUOTE ITS TOUCHY UNQUOTE. FRYE ASKED PCI TO COME TO HOME OF MARJORIE LOFTICE IN DALLAS WHERE SHE WOULD MAKE CONTACT. PCI AGREED TO DO SO FRIDAY NIGHT, AUGUST 21, 1959. FRYE ASKED PCI ABOUT A DOCTOR OF SHAWNEE, OKLAHOMA WHO USED TO WRITE PRESCRIPTIONS FOR NARCOTIC ADDICTS WHOM PCI BELIEVES NO LONGER AROUND NAMED VALENTINE OR BALLENTINE. SHAWNEE AND OC DIRECTORIES LIST NO SUCH

PRACTITIONER. FRYE ASKED IF PCI KNEW ANY DOCTOR THEY COULD USE. PCI ASKED HER IF SAM HOOVER OF PASADENA, TEXAS WOULD HELP HER. FRYE INDICATED HE HAD HELPED THEM SOME WITH MONEY BUT COMPLAINED THAT HOOVER'S WIFE MARY WHO IS A REGISTERED NURSE WOULD NOT. PCI INDICATES SHE IS VERY FOND OF FRYE AND ANXIOUS FOR HER SAFETY. SHE STATES FRYE IS DANGEROUS, WILL USE PISTOL FOR POPE ~~FOR~~ IF SHE IS IN FACT WITH HIM, IS AN ACCOMPLISHED BURGLAR AND HAS BEEN A PROSTITUTE, AND BELIEVES FRYE PROSTITUTING NOW FOR EXPENSES OF SELF AND FRIEND. EFFORTS BEING MADE BY INFORMANT TO BORROW HER SISTER'S CAR IN OC AREA FOR TRANSPORTATION TO DALLAS, WHEN DEFINITE ARRANGEMENTS ARE MADE, BUREAU AND DALLAS WILL BE IMMEDIATELY ADVISED. PCI TO CONTACT DALLAS OFFICE ON ARRIVAL. NAMES OF AGENTS TO BE CONTACTED AND DALLAS OFFICE CONFIDENTIAL PHONE NUMBER FURNISHED PCI PURSUANT TO RE CALLS. PCI SHOULD BE HANDLED BY MATURE AGENTS EXPERIENCED IN DEALING WITH HOODLUMS AND INFORMANTS. EXPENSE MONEY BEING FURNISHED PCI UNDER SAC'S AUTHORITY. BUREAU REQUESTED TO SUTEL DALLAS AND OC AUTHORIZATION TO EXPEND AND ADDITIONAL \$200 DOLLARS EXPENSE MONEY IF NEEDED BY PCI, WHO HAS BEEN PAID NO MONEY EXCEPT FOR EXPENSES TO DATE. PURSUANT TO RE CALLS, DALLAS TRACE ALL LD CALLS OF RELATIVES OF FRYE IN DALLAS AREA DURING PERTINENT PERIOD TO DETERMINE, IF POSSIBLE, LOCATION OF FRYE AND POSSIBLY SUBJECT. COPY TO HOUSTON AIR MAIL FOR POSSIBLE FUTURE REFERENCE RE SAM HOOVER. POPE ALLEGEDLY HAS IN HIS POSSESSION AT ALL TIMES A 357 MAGNUM REVOLVER, .45 CALIBER AUTOMATIC, .38 CALIBER STUBNOSE REVOLVER AND A SAWED OFF SHOTGUN. HE HAS SHOT AT POLICE OFFICERS IN THE PAST AND ALLEGEDLY HAS STATED HE WOULD KILL ANY OFFICER ANTEMPTING TO ARREST HIM. HE SHOULD BE CONSIDERED ARMED AND EXTREMELY DANGEROUS. FRYE SHOULD BE CONSIDERED ARMED AND DANGEROUS.
