Re Dallas airtel, 8/20/59.

On 8/19 and 20/59, information was developed that FRYE's mother, RUBY JELSEN had sent a \$50 money order to her daughter, FRYE, as JOYCE THOMPSON, on 6/16/59, at Marshall, Texas. JELSEN was interviewed 8/20/59 by Bureau Agents and admitted sending the above money order and of lying to agents when previously interviewed concerning any knowledge she had of the whereabouts of her daughter. She stated that on 6/16/59 she received a phone call from FRYE giving her instructions about sending the money order. She stated she sent the money order on same date but that Western Union must have had some difficulty as her daughter called back two or three times on 6/16/59 and 6/17/59 asking about the money order as she had not received it. JELSEN maintained that she had no further contact since that time with her daughter. She stated she was tired of the whole affair and would cooperate with the FBI in the future.

Investigation by Bureau Agents at Marshall, Texas, ascertained that the money order was sent from Dallas on 6/16/59 to JOYCE THOMPSON and was actually picked up on 6/17/59 by THOMPSON. No address was given by the receiver and she obtained it by identifying the color of her mother's hair, gray. Investigation is being conducted today at Marshall of all motels and hotels in an effort to obtain further information concerning FRYE and POPE.

On 8/20/59, PCI DORIS HOWARD arrived in Dallas as scheduled. She has made contact with the sister of FRYE, MARJORIE LOFTICE, and RUBY JELSEN. She has made arrangements to meet with JELSEN tonight for dinner and discuss of possible contact with FRYE. JELSEN and LOFTICE have both advised the informant they are convinced that their phones are tapped, by the FBI and therefore do not desire to discuss any matters by phone. It should be noted that after each contact with the informant, LOFTICE and JELSEN have called the FBI Office but have not given full details of discussions with HOWARD. It is believed they are making such reports based on their beliefs that their phones are tapped.

Investigation at Blossom, Texas, concerning father of FRYE, CHARLES ALLEN CLEBURN, was conducted 8/17/59 without result.

Little Rock by airtel, 8/19/59, advised that investigation by that office based on information previously received from Norfolk had been conducted without identification of POPE or FRYE.

Phoenix by airtel 8/19/59 advised that interviews with BILL SWIFT, PAUL CLINITE, and JOHN FLYNN had been conducted by that office, but no pertinent information developed.

Dallas is continuing coverage of LOFTICE, FRYE, and the informant throughout today and any subsequent necessary days in the future in an effort to determine whereabouts of FRYE and/or POPE.

POPE IS HEAVILY ARMED AND SHOULD BE CONSIDERED  
EXTREMELY DANGEROUS. FRYE IS ARMED WITH A .32 CALIBER  
AUTOMATIC, HAS ASSAULTED POLICE OFFICERS IN THE PAST AND SHOULD  
BE CONSIDERED EXTREMELY DANGEROUS.
