Re Dallas airtel to Bureau, 8/21/59; Dallas tel, 8/22/59, and New Orleans tel, 8/23/59.

As reflected in re New Orleans tel, most active and intense investigation presently being conducted at New Orleans utilizing PCI DORIS HOWARD of the Oklahoma City Office, as possible contact with FRYE and/or POPE.

As noted in Dallas tel, surveillance of PCI HOWARD and FRYE's relatives at Dallas on 8/21 and 22/59, negative.

POPE IS HEAVILY ARMED AND SHOULD BE CONSIDERED EXTREMELY DANGEROUS. FRYE IS ARMED WITH A .32 CALIBER AUTOMATIC, HAS ASSAULTED POLICE OFFICERS IN THE PAST AND SHOULD BE CONSIDERED EXTREMELY DANGEROUS.
