SUBJECT ORGANIZATION

On November 20, 1961, PSI WILFREDO ROBAINA, a Cuban refugee who maintains contact with pro and anti-FIDEL CASTRO elements in the Miami, Florida area, advised that as of November 16, 1961, headquarters of the Unidat Para La Guerra are located at 157 West Flagler Street, Miami, Florida, telephone FRanklin 3-9158, and that the director of activities of the organization is MIRTO COLLAZO VALDES. REINALDO PICO RAMON continues to be the popular-proclaimed president of the organization.

SUBJECT

The Miami Office, through logical sources, at the present time is in the process of obtaining names and addresses of all the registered members of this organization and when this has been obtained, the Miami Office will prepare a report concerning this matter.
