1. LOND HAS NO CURRENT UPI CONTACT. THUS CAN ONLY SUGGEST FOLLOWING: WE SHOULD BE ABLE FIND SOME SENIOR AND RESPONSIBLE AMERICAN INDIVIDUAL LOND WITH CONTACT AT APPROPRIATE LEVEL UPI WHO WOULD MERELY STATE THAT IF SUBJECT WAS BEING CONSIDERED FOR MOSCOW ASSIGNMENT WOULD BE IN GOVT INTEREST THAT SHE NOT GO. WOULD MAKE CLEAR THIS UNOFFICIAL EXPRESSION OF OFFICIAL INTEREST AND IN NO WAY DEROGATORY SUBJECT HERSELF.

2. IF YOU AGREE ABOVE, WE CAN EXPLORE AND ADVISE HOW WE PLAN PROCEED. ADVISE.
