2. FYI: MEXI IN TOUCH THRU LITAMIL-2 WITH WIFE LT ENIO LEYVA  
FUENTES. (LITAMIL-2 WAS BEST MAN AT THEIR WEDDING). WIFE RESIDES WITH  
TWO CHILDREN MEXI, APPARENTLY ON GOOD TERMS WITH LEYVA. STATION WILL  
BE ALERT FOR INFO HIS TRAVEL FROM HER, AND OF POSSIBILITY PERSUADING  
HER ENTICE LEYVA FROM CUBA FOR SOME REASON.

3. CONCERNING REF B: STATION HAS BEEN IN CONTACT WITH LITEMPOS.  
PROBLEM LIES IN FACT THAT PRESENT BACKLOG OF REQUESTS NUMBERS  
THOUSANDS. WHEN MEXI GOVT APPROVE VISA REQUESTS THEY ARE NOT LATER  
ADVISED WHEN VISAS ARE ACTUALLY OBTAINED BY APPLICANTS (DURING A
