1. TAMAYO (T) APPEARED WITH WIFE FOR 27 MARCH MEETING.

CONVEYED REF A LINE BUT T GREATLY RELUCTANT APPEAR AT HOME OFFICE AND THUS POSSIBLY INVOLVE WIFE'S FAMILY FURTHER IN HIS PROBLEM. T SAID HE HAD TAKEN FROM HIS OFFICE DOCUMENT ON 1966 SUGAR PROGRAM. IN VIEW HIS DETERMINATION AVOID BRIT AUTHORITIES (SAID HE WOULD GO TO DOMINICANS IF ODYOKE COULD NOT HELP) INSTRUCTED HIM COME TO PBSWING WITH DOCUMENTS MORNING 28 MARCH. THUS T APPEARED AT 1100 HOURS AND IN PBSWING SECURITY OFFICE HE FURTHER BRIEFED BY STA OFFICER WITH

RESULTS AS FOLLOWS:

A. T CLAIMS HAVE LIVED ON FARM NEAR SAYAMO, CURA UNTIL 1959. MOTHER AND FATHER DIVORCED AND FARM OWNED BY MOTHER AND HER BROTHERS. MOTHER DIED SEVERAL YEARS AGO AND FATHER IS ENGINEER FOR NICARAO MINES. T SAYS FARM NEAR PEPEL TERRITORY AND HE ACTIVELY SUPPORTED THEM. *ALTHO QUIKY YOUNG AT TIME HE DEVELOPED MANY*

*CLOSE FRIENDS IN ARMY MANY OF WHOM HOLD HIGH POSITS.*

B. IN 1959 WENT HAVA TOOK CIVILIAN JOB WITH ARMY LEGAL

DEPT. <sup>S</sup> SUPERVISOR WAS CAPT CONCEPCION ALONSO. SHE LEFT CUBA EARLY 1955 AFTER ALLEGEDLY BECOMING INVOLVED IN PLOT AGAINST CASTRO.

C. IN LATE 1958 T TOOK JOB IN ACCOUNTING DEPT OF EXPORT BANK. SUPERVISOR WAS FNU CARBONELL.

D. IN 1961 HE SELECTED FOR COURSE ON ECONOMIC PLANNING SPECIALIZING ON SUGAR. COURSE RUN BY CUBAN AND CZECH INSTRUCTORS. SAYS NO SYSTEMATIC POLITICAL TRAINING RECEIVED AT ANY TIME.

E. IN MID 1961 WAS INTEGRATED INTO NEW MIN FURN TRADE WHERE DID STATISTICAL PLANNING ON SUGAR. EARLY 1962 BECAME CUBAZUCAR ASSISTANT MANAGER. ALSO BECAME CLOSELY ASSOCIATED WITH PROFESSOR MANUEL PERDOMO WHO TAUGHT HIM MUCH ABOUT SUGAR INDUSTRY.

F. IN 1963 WAS APPOINTED CUBAZUCAR REP LOND. SAYS THIS DECISION MADE BY ALBERTO MORA AND PAUL LEON.

G. T CLAIMS NEVER MEMBER COMMUNIST PARTY OR IN MILITIA OR ARMY. TOOK ONLY ONE TRIP OUTSIDE CUBA PRIOR APPOINTMENT LOND. WENT COMECON CONFERENCE BUCHAPEST IN 1962. AT SAME TIME VISITED PRAGUE AND SOFIA.

3. T CLAIMS PART HIS PRESENT TROUBLE COMES FROM ASSOCIATIONS  
HE HAD MADRID LATE NOVEMBER 1964. THAT TIME HE MEMBER DELEGATION  
NEGOTIATING TRADE AGREEMENT WITH SPAIN. PARTICIPANTS WERE RAUL ROA,  
ROGELIO MONTENEGRO, PAUL VOLTA (THEN CURATOR PEP) JULIO IMPERATORE  
*Juan de Sualto*  
(MANAGER NATIONAL BANK), AND ENO SOTO AND ENO PORTELA OF CUBAN  
COMMERCIAL MISSION MADR. AT SAME TIME CURANS HELD CHIEFS OF MISSION  
MEETINGS MADR. ALL THESE MEN MET SOCIALLY WITH CUBAN EXILES SUCH AS  
CAPTAINS JORGE RODRIG AND ALBERTO PLANCO AS WELL AS CUBELA AND MAJOR  
JOSE MOLEON WHO ALSO VISITING MADR. SOCIAL MEETINGS HELD IN FLAT WHICH  
OCCUPIED BY ROA, MONTENEGRO AND TAMAYO. T THINKS THAT ANYONE WHO  
INVOLVED IN MADR IN LATE <sup>N</sup> NOVEMBER 1964 IS NOW SUSPECT. THIS CONNECTION  
SAYS CRISTOBAL VICTORIANO RECENTLY TOLD HIM THAT JOSE MOLEON WAS SHOT

4. T SAYS ORLANDO BLANCO, CUBAN COUNSELLOR SWITZERLAND MAY ALSO BE IN TROUBLE, BECAUSE SEVERAL DAYS BEFORE CUBELA TRIAL, BLANCO GAVE T BOTTLE OF WHISKY FOR CUBELA. T LATER GAVE BOTTLE TO NATALIA BOLIVAR, HEAD OF NATIONAL LIBRARY WHO VISITING PARI. SHE IN TURN TO CARRY IT TO CUBELA. BLANCO WIDELY KNOWN AS CLOSE FRIEND OF CUBELA.

5. T WISHES GO U.S. PRIMARILY BECAUSE JOB PROSPECTS LOOK BEST THERE AND IF REMAINS IN U.K. WILL BE SOURCE OF EMBARRASSMENT TO IN-LAWS.

ALSO DOES NOT BELIEVE WILL BE POSSIBLE FIND SUITABLE JOB IN SUGAR FIELD WITH U.K. FIRMS BECAUSE ALL DO BUSINESS WITH CUBA. CLAIMS TO HAVE BEC<sup>ME</sup>OME DISENCHANTED WITH CASTRO REGIME SOME TIME AGO BUT HAD NO ALTERNATIVE BUT REMAIN IN HIS JOB TO GAIN BUSINESS EXPERIENCE. AT THIS POINTS FEELS HE WELL QUALIFIED IN SUGAR MARKETING AND WELL AS NUMBER RELATED FIELDS. CLAIMS HAVE BROAD KNOWLEDGE CUBAN SUGAR MARKETING, PRODUCTION, AND POLICY AS WELL AS OTHER ASPECTS CUBAN FOREIGN TRADE.

6. UNDER CONDITIONS WHICH INTERVIEW CONDUCTED HESITATED PROBE TOO DEEPLY IN ORDER NOT BE LATER ACCUSED OF BLEEDING HIM OF INFO AND THEN TURNING DOWN APPLICATION GO PBRIME, IF THAT OCCURS. HOWEVER, DURING INTERVIEW T GAVE EVERY IMPRESSION PROVIDING STRAIGHTFORWARD, FRANK ANSWERS

AND INTIMATED THAT HE HAD MUCH MORE INFO WHICH WOULD BE OF VALUE TO OBYCKE. HAD WITH HIM BOOKLET PUBLISHED BY CUBAZUCAR ENTITLED "STATISTIC INFORMATION OF THE EMPRESSA CUBAZUCAR" DATED JANUARY 1 TO 31, 1966. CLAIMS THIS MONTHLY PUBLICATION BUT CONTAINS STATISTICS FOR ENTIRE YEAR 1966. DID NOT ASK KEEP THIS BOOKLET BUT DID COPY INDEX WHICH WILL BE SENT SEPARATELY. T ALSO ANSWERED QUESTIONS CONTAINED DLS 88849. WILL SEND ANSWERS SEPARATELY BUT IN GENERAL THEY JIBE WITH AMSNAKE INFO. T ALSO SAID HAD SOME KNOWLEDGE SOVIET-CUBAN TRADE AGREEMENTS. AS EXAMPLE SAID CUBAN RECEIVE \$20,000,000 EACH YEAR FOREIGN EXCHANGE FROM SOVIETS AS PART SUGAR AGREEMENT.

7. AT THIS JUNCTURE T HAS COMPLETED VISA APPLICATION<sup>N</sup> FORMS AND

HAS RETURNED TO IN-LAWS HOME TO AWAIT FURTHER WORD FROM US. T TOLD HE SHOULD EITHER TRY STALL FOR MORE TIME BY CONTACTING HIS OFFICE AND SAYING ONLY REASON HE DELAYING RETURN TO HAVA IS BECAUSE OF ILLNESS WIFE, OR CONTACTING HOME OFFICE AND TRY REGULARIZE HIS STATUS. HAVE LEARNED VIA BAIEN THAT LOCAL CUBANS KNOW HE IN LOND BUT DO NOT YET SUSPECT HE DEFECTED. AT ABOUT 1200 HOURS 28 MARCH RAUL VOLTA TELEPHONED OSMANI

MARTINEZ IN HAVA AND THEY DISCUSSED T. MARTINEZ SAID T SHOULD COME HAVA SOONEST AND VOLTA SAID HE IN LOND BECAUSE OF SICK WIFE. VOLTA ALSO SAID THEY WATCHING SITUATION CAREFULLY AND WOULD KEEP HAVA ADVISED. NO SUGGESTION THAT T HAD DEFECTED MADE BUT ALSO LOND HAS NO IDEA WHAT VOLTA MEANT WHEN SAID "THEY WATCHING SITUATION CAREFULLY". ANY CASE STILL <sup>THINK</sup>

T IS NOT PROVOCATION.

8. AT THIS POINT BELIEVE T DOES HAVE INFO OF VALUE AND WOULD PROBABLY BE WORTH GRANTING HIM PAROLE STATUS. FEEL HE WOULD COOPERATE IN FULL DEBRIEFING AND PROVIDE USEFUL INFO. SUGGEST COMBINATION OF AMRAIN, AMSNAKE AND T WOULD PROVIDE ALMOST ONE HUNDRED PERCENT <sup>CO</sup> COVERAGE OF CUBAN SUGAR INDUSTRY AT THIS POINT IN HISTORY. DECISION ON T DOES NOT HAVE TO BE MADE IMMEDIATELY BUT SHOULD BE DONE SOON. IN MEANTIME WILL KEEP ABREAST DEVELOPMENTS VIA BAIRN.
