
Dear Mr. Breckinridge:

We also respectfully request that your Agency make Mr. Dan Niesciur available for an interview by HSCA staff members.

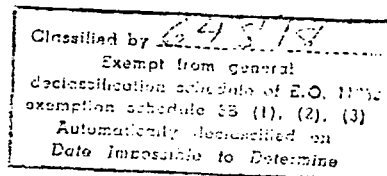
