4. PLAN IS TO HAVE ANDERSON AND GARCIA PICK UP ALVARADO AND BRING HIM TO APARTMENT. MEXICAN POLICE WILL ACCOMPANY TO APARTMENT BUT WILL NOT REPEAT NOT ENTER BUILDING. ANDERSON ALONE WILL INTERPRET FOR WOODHEAD.
5. WILL HAVE RESCIGNO IN A BEDROOM TO MONITOR AND RECORD INTERROGATION. RESCIGNO WILL NOT BE BLOWN TO ANDERSON, GARCIA OR TO MEXICANS.
