1. MORNING 2 DECEMBER ODENVY REP FINALLY RECD GUIDANCE FROM ODENVY HQS WHICH ASKED HIM PROCEED ALONG LINES REF. MATTER DISCUSSED WITH ANB AND DCM AND CABLE TO DEPT VIA KUBARK CHANNELS BEING PREPARED WHEN INANITION ADVISED THAT INFO FROM LAUSANNE (PRESUMABLY FROM PHONE COVERAGE) SHOWED THAT GIBSON PLANS LEAVE SUISSE 2 OR 3 DECEMBER AND TRAVEL TO FRANCE.

2. GIBSON ADDRESSES FRANCE AS FOLLOWS. OFFICE, PARIS BUREAU OF "REVOLUTION", PHONE ELYSEE 66-44. PRIVATE, 26 AVENUE SIMON BOLIVAR, APT 674, PARIS XIX.

3. DEFER TO HQS RE FURTHER ACTION RE GIBSON. WILL CONTINUE MONITOR ANDERSSON AND "REVOLUTION" IN CONNECTION WITH OUR LCHARVEST PROGRAM.
