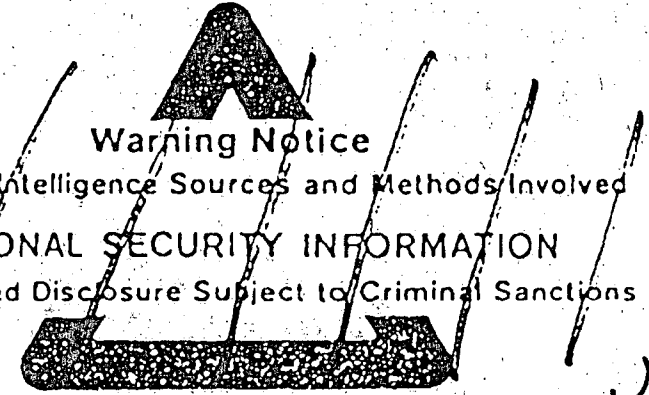

MEMORANDUM FOR: Special Assistant, DDS&T

SUBJECT : Request from House Select Committee on Assassinations

1. (U) In response to your request of 26 July 1978, we have located two coverages of Mexico City. The first is an unclassified aircraft mapping mission taken on 8 February 1967. This coverage is clear, large scale, 9 x 9 format imagery which covers all of Mexico City proper. However, this coverage will not hold up to magnification. We have in our possession 49 frames of a duplicate positive of this imagery.
