TO GALBOND AND PONCHAY

1. ON 26 MAY AMHAWK AND VARGAS GOMEZ LUNCHEd WITH RUBIO PADILLA ON LATTER'S INITIATIVE. AMHAWK AND VARGAS REPORTED SEPARATELY TO PARLETT THAT MEETING HAD BEEN COMPLETE FAILURE. RUBIO TOOK SAME POSITION HE ENUNCIATED IN PAST TO PONCHAY AND PARLETT: EXCEPT FOR AMHAWK HE WOULD HAVE NOTHING TO DO WITH FED PEOPLE. CLAIMED HE HAD ONLY IMPORTANT ODYOKE CONTACT; HE EXPECTS FRENTE TO FAIL BECAUSE ITS UNSOUND COMPOSITION. AMHAWK AND VARGAS TOLD PARLETT THEY CONSIDER ANY FURTHER DEALINGS WITH RUBIO WASTE OF TIME AND THAT HE WOULD BE DEFINITE LIABILITY TO FED EVEN IF HE DID JOIN IT. HOWEVER IN ORDER AVOID PAINFUL BREAK VARONA LEFT DOOR OPEN FOR RUBIO ASSOCIATE HIMSELF FRENTE IN FUTURE.
